### Comments:

- 1) The Council has received a total allotment for FY 2023 in the amount of \$1,501,328. The Council received a no-cost extension for the project period, which now runs through September 30, 2025. The final report is due January 28, 2026.
- 2) The Council has received a total allotment for FY 2024 in the amount of \$1,500,684. The obligation and project periods are through September 30, 2025. The final report is due January 28, 2027.
- 3) The Council has received a second allotment for FY 2025 in the amount of \$344,486, bringing the cumulative total to \$676,694. Congress passed a Continuing Resolution (CR) through September 30, 2025, however, there were no budget tables so we are unaware of the award amount. We are continuing to assume level funding and anticipate receiving the Noices of Award by mid-May. The obligation and project periods are through September 30, 2026. The final report is due January 28, 2028.
- 4) Forecasted Operating/Administrative Expenses are higher than typical due to the Comprehensive Review and Analysis project.




