- Caregiver support, housing, and employment were top of mind for our survey takers.
- While ADDPC is known for serving the I/DD community in certain circles, there's absolutely room for improvement.
- We must develop new relationships and partners to accomplish our goals.
- There's a need to leverage technology differently to reach our audiences.
- Our grants programs is not used to its full potential, with the majority of survey takers not aware we offered grants.

"I did not have enough time to complete the applications. I misunderstood some of the questions. The application it's so mirrors the Federal grant application, which makes it more difficult for a small businesses and nonprofits to understand and complete the application. For smaller grants like conference sponsorships, that require a match, excludes agencies that don't have cash on hand order new companies that don't have cash at all. The video about completing the application was helpful but I feel the application itself is exclusionary."

"Very cumbersome and confusing application process"

"Availability for rural small programs without city resources"

"The application is outdated.
There should be a question
and answer box just like this. It
takes a lot of time to have to
retype the questions asked and
then add answers."

"It was the hardest grant I've ever applied for. I think using Google Forms or something similar would really help applicants to simplify the process. I know it's a federal grant so it will be harder but the form will be the same for everyone and save time."
