# Why is Self-Determination Important

- **Empowers Personal Choice**. Gives individuals control over their lives, allowing them to make decisions that reflect their own goals, values, and preferences.
- Builds Confidence and Independence. Supported decision-making provides a framework to make choices with guidance, increasing self-confidence and independence.
- Enhances Quality of Life. When individuals are empowered to make their own decisions, they experience greater satisfaction and well-being.
- Respects Rights and Dignity. Self-determination emphasizes the right to make personal decisions, promoting dignity and respect for each person's autonomy.
- Encourages Growth in Self-Advocacy. Supported decision-making fosters skills in self-advocacy, allowing individuals to communicate and advocate for their needs.
- Strengthens Social Connections. Choosing supporters to help in decision-making builds trusting relationships and reinforces community ties.
- Reduces Over-Dependence on Guardianship. Offers an alternative to full guardianship, providing support without limiting rights, and emphasizing empowerment over restriction.

## SDM in a Nutshell

- Prior to SDM being signed into law, individuals and families were presented with few options.
- SDM is an alternative to guardianship, where the individual forms a team of supporters to help them in areas of their lifer (healthcare, finances, education).
- The individual, with supports, will assess their strengths and areas where they may need support.
- The individual will then choose supporters for those areas they need support.
- The supporter will help in accessing information, understanding content, and communicating decisions (e.g., a healthcare supporter may attend doctors' appointments, communicate with providers about symptoms, and discuss, in an accessible manner, treatment options and side effects).

#### Supported Decision-Making Agreements

#### What is Supported Decision-Making?

Supported decision-making means a person with a disability can get help when making important life decisions. You can get assistance in areas like deciding on where to live, finding a job, pursuing education, and managing your finances. You choose a trusted family member or friend to be your supporter.

Arizona passed a supported decision-making law which can be found at <a href="https://www.azleg.gov/viewdocument/?docName=https://www.azleg.gov/ars/14/05722.htm">https://www.azleg.gov/viewdocument/?docName=https://www.azleg.gov/ars/14/05722.htm</a> in June 2023. Now, individuals in Arizona can enter into supported decision-making agreements.

#### Why is Supported Decision-Making Important?

Supported decision-making is an alternative to guardianship and it allows you to receive the support you need to make decisions. A guardianship arrangement can be very limiting. With supported decision-making, you keep your individual rights and your independence.

#### What Are Some Things Supporters Help With?

Supporters can play multiple roles. Supporters can help gather information. For example, a supporter can help gather information about classes if the individual wants to pursue education. Supporters can help explain complex concepts, like medical treatments and procedures. The supporter can help gather information on where to live or work. Supporters can help gather important documentation like applying for public assistance. The supporter can also communicate with a landlord or a social services provider for you and make sure your choices are respected.

#### How Can I Create a Supported Decision-Making Agreement?

You can create a supported decision-making agreement by choosing a supporter and signing an agreement. In the agreement, you can choose what types of decisions you would like help with. The agreement must be in writing. You and your supporter must sign the agreement in front of two witnesses or a notary. The agreement lasts as long as you want it to, and you can end the agreement at any time.


