Comments:

- 1) The liquidation period for FY 2018 funds is now back to the original September 30, 2020 deadline. The ACL addendum to the previous 'Grant Flexibilities Guidance' issued on April 28, 2020 takes back the liquidation extension through September 30, 2021 and the obligation period through September 30, 2020.
- 2) The original obligation period for FY 2019 funds was through September 30, 2020, but is now through September 30, 2021 with liquidation through September 30, 2022.
- 3) The Administration for Community Living (ACL) approved a one-time special condition for FY 2019 that will allow grantees to complete the work authorized by September 30, 2021. This project period remains the same, however, the obligation period has been extended to September 30, 2021.
- 4) The Council has received an additional allotment for FY 2020 in the amount of \$48,860 bringing the total FY 2020 award amount to \$1,536,283. The new obligation and project period is through September 30, 2021, with the liquidation of funds through September 30, 2022.
